**\*Only those who have been notified directly by a specific municipality or support organization can register and apply for this offer.**



### Application Guidelines

#### [What is Hello! Baby Box?]

For those who are 22 weeks as of application (11 May 2022) or later pregnant, we will donate the following childcare items needed for newborns.

2 packs of Pampers newborn size diapers / 1 bottle each of additive-free detergent and fabric softener / 1 bottle of baby soap / 5 packs of wipes / underwear set for newborns (kimono-style onesie with bottom snaps or open-front bodysuit, etc.) / toys / relaxation goods for mothers / 1 toothbrush for adults, etc. \*The contents of the Box may vary slightly.

Please pre-registration by 5/10 !

**Just a few simple entries and you'll be registered in no time!**

- You may register your application in advance from the date you receive this notice until the day before the actual application date (May 10).
- **We recommend that you register as early as possible, as those who have pre-registered will be given priority! In the event of a large number of applications, those who have pre-registered will be given priority in the selection process.**  
\*Only those who meet the application requirements will be considered. Please read the application conditions carefully on the next page. Please note that those who do not meet the application requirements will not be able to register.
- Pre-registered applicants will be contacted by e-mail or mail before May 10 (the actual application date) with application instructions. Even if you have pre-registered, **please do not forget to submit your actual application as it is required.**

**Pre-Registration Period:** From the day you receive this notice to 23:59 on May 10

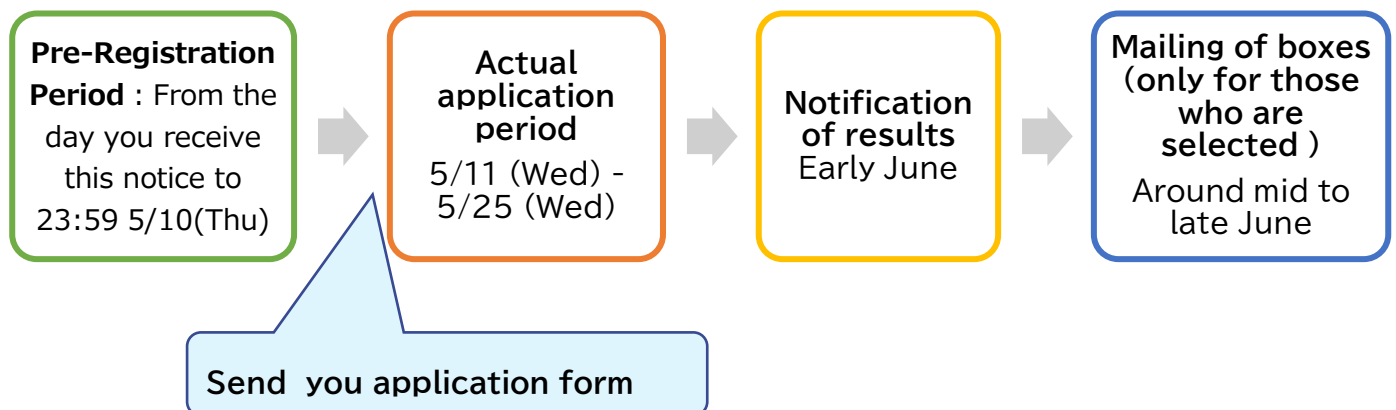

## 【Process from Pre-Registration to Box Mailing】

### 【Application Requirements】

\*Only those who meet the following application requirements are eligible for pre-registration. Please note that those who do not meet the conditions cannot pre-register or apply.

To apply for receiving the Hello! Baby Box, you must meet all the requirements 1-3 below.

\*Foreign nationals are also eligible to apply.

\*If it is difficult for an expectant mother to apply in person, her spouse, partner, family member, or supporter may apply on her behalf. In such cases, a copy of the mother-child handbook or other documents must be submitted.

### 1. At the time of application (as of May 11, 2022), you are 22 weeks pregnant (stable period) or later.

The diapers in the Boxes are newborn size and are intended to be given to those who are before delivery.

### 2. You are in either of the following situations.

\*Those to whom only to F applies may not be eligible depending on the reason.

- A. Pregnancy in adolescence (under 20 years old) or students (including over 20 years old).
- B. A household with multiple children (3 or more children under 18 years old, including the child whom the person is currently pregnant with) \*if you have unborn twins, you can count them as 2 children.
- C. Unmarried or single parent
- D. Pregnancy with intellectual disability, mental illness, or mental instability
- E. Being a refugee, in the process of applying for refugee status, or on provisional release
- F. Others not listed above who have difficulty preparing newborn supplies and need assistance.

### 3. Income requirements

There are income requirements to apply. For more information, please refer to the pre-registration form directly from the link or URL on the first page of the pre-registration form.

\*Applicants who meet the income requirements may apply \*Even if you do not meet the income requirements, you may still apply as long as you meet the requirements above. However, the priority is given to those who meet the income requirement.

**[Application Period]\*After pre-registration, actual application is required.**

**May 11, 2022 (Wed) 12:00 (noon) - May 25, 2022 (Wed) 23:59**

Applications will not be accepted after the deadline for any reason.

#### **[Documents to be submitted at the time of actual application]**

A copy of the cover page of the mother-child handbook and a recent pay stub showing income status, if possible, must be submitted at the time of actual application. \*Not required at the time of pre-registration.

#### **[How to apply]**

Those who have pre-registered will receive an application form by email or mail by Tuesday, May 10, the day before the actual application date. Please enter the application form via the application form link or QR code in the guide, fill out the required information, attach the required documents listed above, and send it to us.

#### **[Selection]**

If the number of applicants exceeds the maximum number, the selection will be made internally. Even if the number of applicants does not reach the maximum number, those who do not meet the eligibility requirements will not be selected. Please note that we will not be able to provide details of the selection process.

#### **[Application Results]**

Save the Children will select applicants based on the submitted application forms and documents, and will notify all applicants of the results by e-mail or phone.

#### **[Shipping]**

The Boxes will be shipped in **mid-June**. Shipping may be delayed in case of bad weather or natural disasters.

##### ◆ Confirmation of application details

We may call or e-mail you to confirm your application details. Please be sure to include a phone number and e-mail address where we can reach you and provide the approximate time of day you are available to be called. If you are using a cell phone carrier email (@ezweb.ne.jp, @docomo.ne.jp, etc.), please make sure that you can receive email from @savethechildren.org.

##### ◆ Data of submitted documents

We use a highly safe and secure form for the data of application documents. We will also destroy all submitted documents after the selection process.

##### ◆ Information entered for application

We may use the information provided in the application form for our statistical analysis,

activity reports, social awareness-raising activities, policy advocacy, etc. in a form that does not identify individuals.
